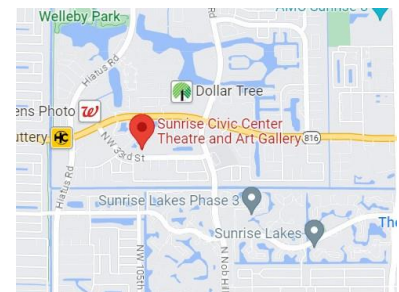

All Florida artists and GCWS Members may enter 1 or 2 paintings. **This gallery requires a jpg of each entry for insurance purposes.** So please read below. **PLEASE READ THE FINE PRINT**

MEDIA

Entries are limited to water media including any combination of watercolor, tempera, gouache, acrylic, casein, ink, charcoal, gesso, watercolor crayons, pencils and pens including metallic. One must exclude water-soluble oils as well as any other similar substance.

ACCEPTABLE SURFACES for watercolor are substrates created for watermedia. For example: paper, clay coated surfaces (Clayboard, Aquaboard, Ampersand), synthetic surfaces, (Yupo, Tiger Rag), illustration board and flat watercolor canvas, (New) wood or canvas panels, gallery/ museum wrapped canvas (no staples showing) and must be $\frac{3}{4}$ " - 2" Deep and cradled board. (painted directly or mounted to board must be $\frac{3}{4}$ " - 2" Deep). Watercolor Collage is acceptable, but newspaper, magazine or non-watercolor material cutouts will not be accepted. Works must be original (not a copy of another artist's work) and must be completed by a single artist (not a collaboration with another). Work must have been completed within the last three years; any submitted work must not have been previously displayed in a GCWS judged show. (Nova show exempt). **NO NUDES ALLOWED**

NEW SURFACES: Wood or Canvas Panels, Gallery Wrapped Canvas, and Wooden Cradle boards



Entry and fees:

Artists may enter one or two paintings. A non-refundable fee of \$30 for GCWS members, \$35 for non-members, must accompany the entry form. No changes can be made after entry is received. No refunds will be made. All entries must be labeled on the back (upper right) with the artist's name, phone number, title, value and whether or not the painting is for sale.

Eligible Presentation - Sizing and framing requirements:

All types of frames are acceptable except those that are ornate or heavy. Paintings must be Framed unless mounted on a cradle board $\frac{3}{4}$ " - 2" deep with finished sides or be painted on wrapped canvas $\frac{3}{4}$ " - 2" deep. All paintings not protected by plexi or glass must be varnished. Wood or canvas flat panels must be framed. Saw tooth hangers are not permitted. Maximum size frame/artwork is less than 42" in any direction. (New) The minimum size of an unframed painting (image) is 10" x 10". Mats are optional with no color restrictions. Work must be sturdily framed under Plexiglas (preferred) or glass, wired and ready for hanging (work will be rejected if it does not comply and fees will NOT be refunded.)

CONDITIONS AND LIABILITIES:

THE SUBMISSION OF ENTRIES TO THIS COMPETITION SHALL CONSTITUTE AN AGREEMENT ON THE PART OF THE ARTIST TO THE TERMS AND CONDITIONS AS SET FORTH IN THIS PROSPECTUS AND BY-LAWS. ALL WORKS MUST REMAIN FOR THE DURATION OF THE SHOW UNLESS APPROVAL IS GIVEN BY THE EXHIBIT CHAIR.
